DIRECTIONS: From Verranzo Narrows Bridge & Kennedy Airport:
Follow signs to Belt Pkwy/Long Island East. Take Belt Pkwy East past Kennedy Airport. After Kennedy Airport stay in left lane & look for signs to Southern State Pway East. Take Southern State Pkwy East to Meadowbrook Pkwy North to NY-24 Hempstead Turnpike East (exit M4). On Hempstead Turnpike get in left lane & make left at first light (Merrick Ave). Eisenhower Park is on your right. Right into parking lot for pool.

From Whitestone & Throgs Bridges: Take Cross Island Parkway South to exit 29, Grand Central Parkway East. Grand Central Pkwy to Meadowbrook Pkwy South (Jones Beach). Get off Meadowbrook Pkwy at NY24 East, Hempstead Turnpike. See above directions.

From LaGuardia Airport: Take Grand Central Parkway (Eastern Long Island) to Meadowbrook Parkway. Follow above directions.
