- FEES:** Individual events are \$3.00 per entry. Relay events are \$8.00 per entry. Checks must be made out to **Newburgh Sharks**.
- CONDITIONS:**
1. Metro LSC clubs will be given priority on a first come/first serve basis and must be received by Friday, May 5<sup>th</sup>.
  2. The final entry deadline for this meet is Wednesday, May 10<sup>th</sup>.
  3. Entries received between Saturday, May 6<sup>h</sup> and Wednesday, May 10<sup>th</sup> will be entered in the order they were received, regardless of LSC affiliation, as space allows.
  4. USA Swimming, Inc., Metropolitan Swimming, Inc., Newburgh Enlarged City School District, Newburgh Sharks and their agents or representatives shall be held free and harmless from all liabilities or claims or damages arising by reason of injuries to anyone during the conduct of this meet.
- RULES:** Current USA Swimming rules will govern this meet. Metropolitan LSC warm-up procedures will be in effect. All events are timed finals. Swimmers may enter up to four events per session.
- ELIGIBILITY:** All swimmers must be USA Swimming registered. Age as of the first day of the meet will determine eligibility for age group events. All persons on deck must have current USA Swimming credentials.
- AWARDS:** Ribbons will be awarded for the top six finishers in the 8 & Under, 9/10, 11/12, and 13/14 events.
- SEEDING:** Seeding will be conducted at the beginning of each session utilizing a scratch sheet procedure. Heat sheets will be posted and distributed.
- ADMISSION:** There will be an admission charge of \$3.00 per adult per session. Admission will include a psych sheet.
- CONSESSION:** A concession and apparel stand will be available in the pool balcony during all sessions.
