- FACILITY:** One 8 lane 25-yard course. A 20 yard lane will be provided for continuous warm up/warm down

- SESSIONS:** Session #1 Friday, November 27th – Warm Up: 10:00 AM / Start: 10:45 AM / End: 2:00 PM
Session #2 Friday, November 27th – Warm Up: 2:00 PM / Start: 2:45 PM / End 6:45 PM
- FORMAT:** **All events are timed finals. Deck seeding will be used.**
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet.
Age on **November 27th, 2009** will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration.
The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** .

- DEADLINE:** **Entries must be received by : November 13, 2009**

An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days of your original email.
- ENTRY FEE:** An entry fee of **\$3.00** per individual event must accompany the entries.

Payment must be received by **November 20** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- WARM-UP:** **General Warm-Up**
- SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches and which swimmers will not be participating in the session.
- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** Ribbons: 1st–8th place in all age groups. Separate awards for the 10 & Under and 11-12 Age groups in the 400 IM and the 500 Free. Separate awards for the 13-14 and 15 and Over in the 400 IM. All awards will be given only to a coach or team representative at the end of the meet. No individual awards will be given out. Awards will not be mailed or forwarded, except in the case of computer failure.

SAFETY: Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
