Athletes, parents and children are restricted to the pool area and spectators stands and are not authorized to be in any other part of the building. Offenders will be ejected

from the facility.

FORMAT: Timed Finals Events will be run fast to slow, alternating girls/boys

Deck Seeding All Swimmers must provide their own Timers & Counters

ELIGIBILITY: Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

Age on OCT 28, 2017 will determine age for the entire meet.

SWIMMERS: Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of

any disability prior to the competition.

ENTRIES: Swimmers may enter 2 Individual events per session,

Entries are accepted on a first come, first served basis. Entries received after the entry deadline will only be accepted if the meet is not full. Deck Entries are NOT permitted. All Entries <u>must</u> be sent as a Hy-Tek or TU file. Manual Entries <u>will NOT</u> be accepted. Mail payment along with Meet

scratch sheet provided at Session 2 warm up.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid

USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do

not possess these credentials will be required to leave the deck area.
