- FACILITY:** **6 Lane by 25 yard competition pool**
Daktronics Timing System, with 6 lane scoreboard

- SESSIONS:** **Session 1 – Ages 10 & Under, 15 & Over 8:00am Warm Up, 9:05am Start Time**
Session 2 – 11 and Over * 2 Hour Maximum – 1:15 Warm Up, 1:45 Start Time
Session 3 – Ages 11/12 & 13/14 4:30pm Warm Up, 5:35pm Start Time
*** Time Trials may be available – Time Permitting, \$5 per event**
- FORMAT:** **This is a Timed Finals Meet.**
This meet will be Deck Seeded; Scratch sheets are due to the Administrative Table 30 mins prior to the start of the session.
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet.
No “Deck Registrations” will be accepted
Age on **January 5, 2019** will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration.
The athlete (or the athlete’s coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** All Athletes are limited to enter 4 events per session, except session 2 – 1 event only
Deck entries will not be accepted.
NT’s will not be accepted. Host team reserves the right to enter NT’s.
Entries are by invited teams only. Hy-Tek Email entries will be accepted

- DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro team’s entries must be received by **December 20, 2018**
2: The final entry deadline for this meet is **January 1, 2019**
3: Metro entries received between **September 1, 2018** and **December 20, 2018** will be entered first.
Entries from other LSC’s will be entered in the order they were received, as space allows.
An email confirming receipt of entries if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days of your original email.
- ENTRY FEE:** An entry fee of **\$5.00** per individual event must accompany the entries.
Make check payable to: **Sachem Swim Club of Long Island, Inc.**
Payment must be received by **1/2/19** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- WARM-UP:** General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes will be available for the remaining 10 minutes. Lane assignments will be distributed along with the scratch sheet each session.

- SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches and which swimmers will not be participating in the session.
- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** **12 and Under will receive Awards – Medals 1st-3rd Place Ribbons 4th-6th**
No Awards will be given for Session 2

- RULES:** The current USA Swimming Rules and Regulations will apply.
The USA Swimming Code of Conduct is in effect for the duration of the meet.
The overhead start procedure may be used at the discretion of the meet Referee.
- SAFETY:** **All swimmers must wear footwear upon leaving the pool area.**
Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. **“Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer’s legal guardian, to ensure compliance with this requirement”**
- WATER DEPTH:** USA 2011 - 202.3.7 "The meet announcement shall include information about water depth measured for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."
1 Meter – 15 Feet, 5 Meter – 12 Feet

- AUDIO/VISUAL STATEMENT:** **Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms or behind the starting blocks.**
- DRONE OPERATION:** **Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.**
- DECK CHANGING:** Deck changes are prohibited.
- ADMISSION:** **Admission \$5.00 per session**
Programs \$2.00 per session
- MERCHANTS:** A concession stand may be available. No glass will be permitted on the deck.
A Swim Vendor may be available throughout the entire meet
- PARKING:** **Free Parking available in school parking lots**

DIRECTIONS:

Long Island Expressway to Exit 63. Head North on North Ocean Avenue, until you reach Granny Road. Make a right on Granny road and Sachem east is on the left about ½ mile down the road. The school is set back way off the road. It is your second right after passing the elementary school
